the BoT, The Doherty Old Students Endowment Fund BoT Chairman, General Kayode Oni (Rtd) (1965) and other BoT members, Immediate Past President, Dr. Michael Abiodun Arokodare, PhD, FCA, (1976) Distinguished former Exco Members, Honourable Newly Sworn-in Exco members, All Former Presidents DMGS-OSA, Leaders of Class Sets, Distinguished Fellow Alumni members, Ladies and Gentlemen,

I want to specifically thank Dr. Arokodare for his leadership, untiring efforts intellectually, generosity and devotion to the cause of our Association. He has left us a big shoe. Same goes to his wife who has stood solidly with us in these last two years.

My appreciation goes also to the Board of Trustees ably led by Prof Ayodele Omotoso and also the Doherty Old Students Endowment Fund BoT led by our respected General Kayode Oni. I also thank all

past Presidents and outgoing Excomembers for their services in sustaining our Alumni Association over many years.

Permit me also to commend all those who participated in the justconcluded elections. The spirited campaigns and the active participation of members reaffirm the strength of our young democratic process. I particularly acknowledge my co-contestant, Mr. Oni Williams for his passion for our community's well-being. I look forward to working collaboratively with all stakeholders in the overall interest of our Alumni Association.

Our guiding principle remains simple and powerful: DMGS and DMGS-OSA all the way.

This appreciation will be incomplete without mentioning our **National Electoral Commission** (NEC) under the leadership of Prince Ayodele Jegede that conducted the last elections with several new innovations without compromising the integrity of the elections. 3. Assumption of Duty
Although we are officially
assuming office today, it is
important to say that we have
been contacting ourselves
informally as newly elected Exco

members since the conclusion of our elections —

engaging, consulting, and preparing for the work ahead. I can say without a doubt that all Exco members are committed to:

- Integrity
- Humility
- Innovation
- Transparency
- Accountability

We shall be sharing full details of our budget and agenda in the coming weeks. While we are your elected officers, we cannot do this alone. The support of all shall be needed - BoT members, past Exco members, Class Set leaders and individual members of our Alumni association. I thank all our leaders

who have reached out to me with their advice, support and availability to assist whenever necessary.

4. The Endowment Fund The Endowment Fund that we launched during the 70th Anniversary under the outgoing Exco is up and running with its **BoT and Management Committee** in place. We shall endeavour to raise more money for this fund through class sets, individual internal donors as well as external ones. We shall come back to all class sets on this in the very near future as we seek to build the fund to enviable heights.

It is hoped that in the next one or

two years, funds generated from this fund will support the DMGS infrastructural development, scholarships, welfare and all other things allowed by the Endowment Fund Constitution.

5. Committees
In pursuit of a more effective
administration, we shall recognize
the need to work with both
Management and Adhoc
committees in accordance with our
constitution. We shall involve all old and younger sets - in the
Committees of our Association.
Many Committees will be

inaugurated or constituted within the next few weeks, aligned with the provisions of the DMGS-OSA Constitution and our renewed focus on operational excellence. We will call on fresh energies and renewed committed members with diversity of thought to support the next phase of our development. I am therefore encouraging all our members including all those who contested the last elections to be available whenever prompted by the newly inaugurated Exco.

6. Electronic Registration
As your Executive Council, we are
determined to give every member

across all sets a voice — your concerns will be heard and your ideas will help shape our future. In order to achieve this, we shall conduct a central electronic registration of every member in every class set showing professions and other details to assist the Association in her constitutional objectives and to also allow every member to network with each other. We are committed to building an administration that is inclusive, responsive, and transformational. All our class set officers are encouraged to co-operate with us to get this done in good time.

7. Finance, Accountability and Transparency In order to ensure we are accountable to all members across the globe, we shall ensure there is annual budgets and regular financial reports to all members. This is in addition to our current external audit functions. We shall be using technology to drive both budget preparation processes and financial reporting of both the DMGS-OSA and the **Endowment Fund.**

8. DMGS-OSA Secretariat
As it is today, our Secretariat
basically reside with the General

Secretary. There shall be a two prong approach to creating a formal setup that can be handed over to the next generations:

- we shall endeavour to establishing a physical place at DMGS including the employment of office clerk.
- we shall use technology to support the Secretariat efficiency and activities using laptops, intranets, electronic filing of records and other office supporting devices.

9. Sets Landmark Anniversary Celebrations

We shall be working with the management of the school and the leadership of class sets to have a

regular time annually to celebrate class sets landmark anniversaries. This will replace the scattered timetable being operated by each set now. This should allow more than one class set to meet in the school at the same time and reduce the impact of our celebrations on students and management of the school.

10. Welfare of members
As members grow older and retire
from former employment, the
welfare needs also grow with age.
Presently, we have left the welfare
of members in the hand of class
sets since they are the only one
that

know their members intimately. While this informal system has been working, we shall in the near future work with class set leaders on how we can make things to work better to take care of our challenged members and make them feel that our Association cares for them.

11. Class Sets Participation
The current participation of class
sets in our activities and finances
are still very low compared with
other old schools within our
category.

We shall shall work closely with existing class set leaderships and prioritising inauguration of more

class sets especially between 2000 and 2024. All these will require support of all members and especially older sets who are in position to encourage the younger sets. The incoming Exco will be call on you shortly on how we can co-operate on this.

12. Conclusion I want to conclude with the words of President Nelson Mandela:

"What counts in life is not the mere fact that we have lived. It is what difference we have made to the lives of others that will determine the significance of the life we lead." What counts now is not that you have attended DMGS at a point in the time past. What really matters is the difference you can make to the next generation.

Together, let us build an Alumni Association that can respond to the yearnings of all members and the future students that will continue to attend DMGS into the unforeseeable future.

I encourage all Set classes to join us as we seek to make a difference in the next two years.
